I Brief Report by Hony. Secretary, Meghalaya State Centre

The Institution of Engineers (India) is the first professional body of India, incorporated in the Royal Charter of England in 1935 with the aim to promote Art, science and practice of the myriad fields of

Engineering and Technology. From a humble beginning in 1920, it is today a multi-disciplinary and nation-wide Organization with international status and bilateral relations with sister societies around the world.

The Shillong Sub-Centre of the IE (I) was established sometimes in the mid of 1966 after the Assam State Centre was shifted to Guwahati. Till then this was the State Centre of Assam. In the year 1985, the Shillong Sub-Centre was renamed as Shillong Local Centre. The construction of the present building of the Institution of Engineers (India) was completed and the Institution started functioning from 1975. Since then, the Institution has grown in myriad ways and the membership strength has risen from mere fifty members to Two hundred sixty nine as on 31/3/2010. The present building is on lease from the Govt. of Meghalaya which is valid till the year 2016. This Committee took a major initiative with whatever sources available to construct the additional multi-storied RCC state of the art building adjacent to the existing building. The work is good progress with the support of our esteemed members and well wishers and if this support continues, the building is expected to be completed by 2010. The major objective of construction of new building is to generate financial resources to make this Centre self sustainable. As of now, this Centre is surviving with a meager grant of about Rs.40,000.00 per annum

Over the years, this Centre has conducted many paper meetings, workshops, technical sessions, seminars both local and national. During the tenure of this committee occasions like World Environment Day, Water Resource Day, Energy Conservation Day and World Telecom Day apart from our Engineers' day were celebrated. The members had the opportunity to attend Seminars outside the State. The Executive Committee also visited the IEI (HQ), at Kolkata and had discussions with the SDG, IEI (I) regarding issues concerning this Centre and also for extending financial assistance for construction of the new building. The Centre received a positive response from the HQ. This General Body decided to hold the next council meeting in Shillong sometime in September 2011 for which Hony Secretary is authorized to send request letter to SDG for placing our proposal in the council meeting and intimating its approval.

The audited accounts were read out by Hony Secy and passed by the house. The auditing charge for the chartered accountant is fixed at Rs.2,500/- and Shri. R. Pal the present Chartered Accountant has been appointed for the next sessions also.

The election of the Executive Committee of Meghalaya State Centre was conducted and the list of members so elected are appended as Annexure-A.

Total 128 members attended the annual general meeting

The meeting ended with vote of thanks to the chair.
